### Supplier RoHS 2015/863/EU Recast Compliance Statement

#### Introduction

St Cross Electronics manufactures cable assemblies and looms made from a variety metal, plastic and elastomeric materials. The purpose of this statement is to clarify the position of St Cross Electronics on compliance with the RoHS directive.

The RoHS (Restriction of Hazardous Substances) directive is an EU initiative aiming to restrict the use of known dangerous chemicals and substances.

As of 22 July 2019, new regulations will come into force stating that any electrical and electronic products must not contain and exceed maximum concentration levels of the following substances:

- Lead (0,1 %)
- Mercury (0,1 %)
- Cadmium (0,01 %)
- Hexavalent chromium (0,1 %)
- Polybrominated biphenyls (PBB) (0,1 %)
- Polybrominated diphenyl ethers (PBDE) (0,1 %)
- Bis(2-ethylhexyl) phthalate (DEHP) (0,1 %)
- Butyl benzyl phthalate (BBP) (0,1 %)
- Dibutyl phthalate (DBP) (0,1 %)
- Diisobutyl phthalate (DIBP) (0,1 %)
